Old Business:

Treasurer

- Installment fees will be the 25th of every month beginning in July.
- BOOST will be offering PAYPAL as a way to pay installment fees. If you choose to pay installments through PAYPAL YOU will be responsible for any surge charges. The QR code will be posted in the Facebook page and will also be posted on the BOOST box inside the gym.
- Please make sure your BOOST account is current. It is **CRITICAL** that funds are in your account especially when payments for meets go out in the fall.
- Any money left in your account at the end of the season will be rolled over to the next season unless you tell Jackie otherwise.
